Each undersigned applicant hereby requests to be supplied with the service or services indicated above by the City of Columbiana, Alabama. I/We agree to pay for the service at the regular scheduled acceptable rates applicable from time to time as set by the City of Columbiana now and at any future time and to comply with the rules and regulations of the City of Columbiana, Alabama, relating to such service. Each of the undersigned also agrees to furnish a security deposit in the amount set by the City of Columbiana, which is security for both garbage service and sewer service and may be applied to delinquent bills for either or both services and, if so applied, shall be replenished by the undersigned as provided by ordinance or regulation of the City of Columbiana.

Each undersigned further agrees that:

1. Liability for all service charges, fees, and penalties is joint and several, and the City of Columbiana may pursue collection against any one or more than one of the undersigned.
2. Each shall be responsible for the safekeeping of all property of the City of Columbiana used in providing service on the premises where service is furnished.
3. Each guarantees free right of ingress and egress by the City of Columbiana employees to any property of the City of Columbiana located on said premises without obstruction (i.e. shrubs, decks, porches, parked vehicles, restrained animals, fences, etc.).
4. Each will keep in good repair all sewer appliances and piping on said premises, first notifying the City of Columbiana prior to having repairs made, and will report immediately to the City of Columbiana any leaks discovered.
5. No supplementary or additional sewer or garbage service may be joined or added to the service provided under this Application and Agreement.
6. The City of Columbiana shall not be liable for damages because of an interruption of service by reason of fires, accidents, inclement weather, act of God, or any other cause beyond the control of the City of Columbiana, and the undersigned agree to notify the City of Columbiana of an interruption of service for any reason.
7. A late penalty of 5% of the current sewer and garbage fees will be added on the delinquent date printed on the utility bill.
8. Discontinuance of sewer service will be as follows:
  - (a) Cut offs and reconnections will be performed Monday through Friday during business hours of each week (8:00 am.- 4:00p.m.) and all applicable costs, fees, and deposits must be paid with cash or money order.
  - (b) A reconnection fee in an amount set by the City of Columbiana will be charged to reinstate service.
  - (c) The account must be paid in full plus the reconnection fee and security deposit before service will be reinstated.
9. Each agrees to be liable for, pay, or reimburse the City of Columbiana for all costs and expenses, including but not limited to a reasonable attorney's fees, and interest at an annual percentage rate of 18%, incurred by the City of Columbiana in collecting or attempting to collect any sum due by the undersigned to the City of Columbiana for services provided under this Application and Agreement; and each waives all rights of exemption as to personal property under the constitution or laws of the state of Alabama and any other state.
10. The City of Columbiana shall have the right to discontinue service without further notice in case of the applicant's failure to comply with this Application and Agreement. Each agrees that any unpaid balance on established account services rendered will be paid promptly at the time service is discontinued.
11. Any unpaid balance for service provided by the City of Columbiana may be transferred to any other account of the undersigned with the City of Columbiana, including an account at some other service location, whether now in effect or as such may hereafter be established.
12. Any unpaid balance for service provided by the City of Columbiana to any of the undersigned, whether at the location for which service is being requested in the Application and Agreement, or at some other location, must be paid before any service will be provided under this Application and Agreement.
